MESSAGE FROM 40TH ANNIVERSARY ORGANISING CHAIRMAN



THE STORY OF BINA PURI



Bina Puri is a combination of two words in which 'BINA' is a Malay word that means 'to construct'. Thus 'Bina' directly reflects the construction activity as the core business of Bina Puri Group of Companies.

Meanwhile, based on the press interview released in Utusan Malaysia dated 3rd December 1994 and The Star dated 28th December 1994, the Group Managing Director, YB Tan Sri Datuk Tee Hock Seng, JP stated that the word 'PURI' is a name of a hill in Bandung, Indonesia.

From the Malay literature perspective, 'PURI' is a Malay word that is rarely used in Malaysia, but more frequently used in Indonesia.

In reference to Kamus Dewan (Dewan Dictionary) published by Dewan Bahasa dan Pustaka (DBP), the word 'PURI' means beautiful residence of a king or a palace.

In justifying whether the 'PURI' means a palace or it refers to a hill in Bandung, the pioneer and the founder of Bina Puri Group of Companies, Dr Tony Tan Cheng Kiat clarified that 'PURI' solely means palace.

In summary, by combining the words 'Bina Puri', it is literally defined AS CONSTRUCTING 'A PALACE'. Analogically this reflects the capability to construct high and beautiful buildings'.

Thus, it is timely that during our 40th Anniversary Celebration, we are once again reminded of how we got our name Bina Puri.





BINA PURI GROUP OF COMPANIES 1975 -2015 LOOKING BACK

Today in the year 2015, we are making another important date in our historical calendar. Under the parenthood of Bina Puri Holdings Bhd, we are celebrating the 40th anniversary of the Group. Let's take a quick glance at the major events in Bina Puri's diary over the past 40 years.





1975-1985

5 June 1975

Establishment of Bina Puri Sdn Bhd as a JKR registered Class 'BX' licensed contractor.

8 June – 2 November 1975


Bina Puri's maiden project – the Construction of the Police Station and Residential Houses in Kepong.

October 1984

Incorporation of Ideal Heights Properties Sdn Bhd (IHPSB) and development of Bukit Idaman Township.

1 October 1985

1st major project from JKR, Jalan Kepong-Selayang with project value of RM63 million. The project was completed in March 1989.







1986-1995

31 May 1990

Privatisation of Sungai Long Industries Sdn Bhd (SLISB) to operate a quary in Hulu Langat.

5 Novemer 1990

Bina Puri Holdings Bhd (BPHB) was incorporated.

1 November 1991 - 30 January 1994

BPSB was awarded the Construction of North-South Expressway from Alor Pongsu to Bukit Merah by PLUS with contract value of RM216.9 million.

June 1992

Easy Mix Sdn Bhd was formed to supply readymix concrete.

15 July 1994

Sabah Office was set up with only 2 staff led by Datuk Henry Tee. 1st project in KK was resurfacing of the Kota Kinabalu International Airport.

6 January 1995

BPHB was listed on the main board of Kuala Lumpur Stock Exchange with Authorized Capital of RM100 million and Paid-up Capital of RM40 million.

8 August 1995

1st venture to India with JV partner Madhucon Projects Ltd.

Bina Puri Construction Sdn Bhd (BPCSB) was formed to compliment BPSB in both civil and building contracts.

15 October 1997

Bina Pari-Bina Primas JV was awarded the Kota Kinabalu-Sulaman Coastal Road with contract value of RM314 million.

9 November 1997

Madhucon-Bina Puri JV was awarded the Vijayawada to Eluru Expressway construction of 75km.

28 March 1998

Moving into our own building – WISMA BINA PURI.

8 October 1998

The first Bina Puri General Assembly was held with an attendance of 231 staff and directors.

7 December 1998

BPSP received the MS ISQ 9002 Quality System Certification from SIRIM.

5 February 1999

BPCSB received the MS ISO 9002 Quality System Certification from SIRIM, on Provision of Construction Services for Building and Civil Engineering Works.

April 2000

Completion of the Hyatt Regency Hotel, Kathmandu, Nepal.

24 May 2002

BPHB was awarded the prestigious MS ISO 9001:2000 Quality System Certification from SIRIM, on Provision of Corporate Services to Subsidiaries & Associate Companies and Investment Holding Activities.

21 July 2002

Successful completion of the Malaysian Embassy building, Beijing, China.

5 February 2004

The Chittorgarh – Mangalwar National Highway Project in Rajasthan, India was successfully completed 2 ½ months ahead of schedule.


19 November 2005

16 December 2007

5 June 2008

6 May 2010

New contract secured, the "Proposed Design, Construct, Complete and Commissioning the Development of UITM Campus Kampong Pinang in Kota Samarahan, Sarawak (RM306.9 million)

1 June 2010

YBhg. Dato' Ir. Wong Foon Meng was appointed as the new Chairman of Bina Puri Holdings Bhd.

21-23 June 2010






