Bina Puri wins job in Brunei

KUALA LUMPUR: Bina Puri Holdings Bhd's unit Bina Puri (B) Sdn Bhd has secured a sub-contract worth RM158.36mil in Brunei.

Bina Puri (B) had entered into a sub-contract agreement with Chuon Tzu Construction Co Sdn Bhd to undertake the infrastructure works for a housing project for a contract sum of RM158.36mil, the company said in a filing with Bursa Malaysia yesterday.

The project is expected to be completed in 36 months.

With the award, the group's current order book stands at RM3.31bil to date. It secured projects worth RM2.62bil in 2010.

The sub-contract is expected to contribute positively to the earnings of the Bina Puri group for the financial year ending Dec 31, 2011. — Bernama
