## Bina Puri awarded task to build Malaysian embassy in Moscow for RM155 million

KUALA LUMPUR --- The Malaysian government has awarded the job to build the Malaysian embassy complex in Moscow, Russia, to the consortium of Bina Puri-Beringin Waja led by leading local construction player Bina Puri Sdn Bhd, a wholly owned subsidiary of Bina Puri Holdings Bhd for the sum of RM155 million.

The embassy complex to be located at Mosfilmovskaya Ulitsa 50, 117192, Moscow, Russian Federation, will be completed within 36 months.

In a statement issued today, Bina Puri Holdings Bhd Group Managing Director Tan Sri Datuk Tee Hock Seng said, "The Malaysian embassy comprises a chancery block, a multi purpose hall and the ambasador's residence sited in three zones and takes into consideration the functions and levels of security of each zone."

"The three-storey chancery block designed with a curved elevation, is sited at the front to afford easy identification from the main street leading into the complex. Modern in approach to complement the neighbourhood, the Malaysian identity *'Kelarai Bertindih'* is reflected on the walls of the chancery block to complete the unique montage. The interiors will also feature Malaysian flavours."

This is the second embassy construction job awarded by the Malaysian government to Bina Puri. To its credit, Bina Puri also undertook the development of the Malaysian embassy and ambassador's residence building in Beijing, China.

Bina Puri has more than 38 years experience in the construction industry. It began its foray in the overseas arena 16 years ago and has a proven track record in delivering. The achievements are reflected in the completion of diversified multi-million Ringgit construction projects, comprising mega infrastructural works such as highways, airport works, waterworks, hospitals, high-rise buildings and land reclamation projects, both locally and overseas.

The hall is designed for a capacity of 200 pax catering for official gatherings, special functions, social and recreational activities.

The ambasador's residence is sited at a corner in the complex grounds with formal lounge and dining located on the ground floor with a separate private staircase to the residence on the upper floors.

This proposed layout for the embassy complex has taken into consideration the existing conditions of the site with the ground floor raised one meter high in order to reduce excavation of the earth and to prevent severe snow from entering the ground floor.

"We are extremely delighted that the government has placed their continued trust in Bina Puri for the construction of government projects both locally and abroad," said Tan Sri Datuk Tee.

Bina Puri's construction portfolio in the international arena also saw the completion of more than 30,000 units of affordable housing for the National Housing Authority of Thailand in Bangkok, Thailand, three major highways in India, including the Vijayawada–Eluru Expressway, Tada–Nellore Expressway in Andhra Pradesh and the Chittorgarh–Mangalwar Highway in Rajasthan.
