ANOTHER DEAL FOR BINA PURI IN SABAH

The Sabah Ammonia Urea (SAMUR) PETRONAS Project – Package 7, Sipitang

KUALA LUMPUR --- Another package of the Sabah Ammonia Urea (SAMUR) project in the state of Sabah valued at **RM 67.23 million** has landed on the lap of Bina Puri Holdings Bhd, further pushing up its unbuilt book order to RM1.52 billion to date.

The latest deal through its wholly-owned subsidiary, Bina Puri Sdn Bhd, is for the "Supply, Fabrication and Construction of Civil Works, Package 7 of Sabah Ammonia Urea (Samur) Project in Sipitang, Sabah awarded by Consortium of Apex Energy Sdn Bhd and PT Rekayasa Industri.

Located in Sipitang Oil & Gas Industrial Park, the world-class SAMUR Project by PETRONAS Chemical Group Berhad consists of a urea plant, a granulation plant and an ammonia plant as well as utilities and jetty facilities

For the above subcontract awards, the scope of works includes foundation works, earthworks, internal drain, concrete works, pipe and masonry works, water proof works, acid and proofing works and others. The mentioned works has been given time frame of eleven (11) months to complete it.

With this award, it is the second package of SAMUR Project awarded to Bina Puri Group. Earlier, in June 2013, Bina Puri received the award for package 3 valued at RM 22.35 million.

"It is another package of SAMUR Project awarded to us after the earlier one, package 3 valued at RM22.35 million awarded on June 2013. We are very proud to work together with Consortium Apex Energy and PT Rekayasa and being able to participate in Sabah development activities especially in this SAMUR project under the PETRONAS Group. For the current year, the Group is currently constructing the new Sabah State Administrative Centre worth RM388.7 million and the KK Time Square worth of RM 470.3 million.
