The truth must be told

What are the reasons for more delays in the opening of KLIA2?

Reflections by B K SIDHU

NEARLY two months ago, there were reports international airport in its early days of opera-stating that KLIA2 would surely get its certifi- tions. cate of fitness by the end of January to facili-

The main contractor – the UEMC-Bina Puri joint venture – pledged to complete the air-port with its certificate of fitness by Jan 31. This new date came about after several

deadlines were not met to the extent that the Government had to establish a task force to monitor the progress at KLIA2, an airport dedicated to low cost carriers.

The certificate would enable the airport operator, Malaysia Airports Holdings Bhd (MAHB), to conduct operational readiness and airport transfer or better known as ORAT.

But the Jan 31 deadline was not met because the infrastructure has yet to get the green light from the Fire and Rescue Department, the Sepang Municipal Council and Indah Water Konsortium.

Rectification works are under way, giving reasons for many to doubt if the airport can be operational by May 2. Against this backdrop, acting Transport Minister Datuk Seri Hishammuddin Hussein

has given a commitment that the deadline of May 2 for the opening will be maintained or the parties responsible would be penalised for delays

He has even said that the ORAT can be car-

ried out by MAHB immediately. Typically, new airports need about six months for ORAT.

Even when the main terminal, KLIA, was built more than a decade ago, it had originally planned for a three-month ORAT period, but took six months. So did Hong Kong's airport, Bangkok's Suvarnabhumi and South Korea's Incheon.

Delays in airport projects are not unique to KLIA2 as it is a complicated infrastructure. Even when airports are opened, many face operational issues.

For instance, Denver airport faced huge bag-gage system problems from day one, while it was not smooth sailing at the Hong Kong

The Doha airport changed its opening date many times and now has fixed it for 2017. So have the authorities in Germany who have delayed fixing the date for the opening of the Berlin airport thus far despite Germany being known for its machine-like efficiency.

So KLIA2 is not alone, but people need to know the truth as to what is really going on given the many misses and delays.

The parties should be transparent about the issues they face.

Is it really true that a large portion of the main terminal is not ready for public occupa-

tion from the fire and safety aspects? Are there problems with the sewerage pipes due to soil conditions?

There are plenty of construction jobs in the market, and the obvious question is whether the contractors have bitten off more than they can chew and that could be slowing down the completion of KLIA2. Are they also facing shortage of resources?

Over a decade ago when KLIA was conceptu-alised, there was a planning committee that dedicated two years just to planning before the start of construction. After the plans were firmed up, it did not accommodate any chang-

Only four main contractors were appointed to build KLIA.

In comparison, KLIA2 has too many contractors in a bid to give many parties jobs, and it also did not lock up its plans, catering to lastminute requests for changes. This could also be a reason for the delay.

To be fair, the third runway, taxiway and other supporting infrastructure were com-pleted in December last year, making Malaysia

the first country in the region to have a third runway for its flagship airport. Enough time has been spend on trying to complete KLIA2, and it is easy to point fingers, but this is an important facility. Some parties ineed to even us to all the delays on factors need to own up to all the delays so far.

Ministry plays down safety issues at klia2

> CCC to be obtained in 2 or 3 weeks, terminal will open 'no matter what'

PUTRAJAYA: The Transport Ministry has played down safety issues at the main terminal bulding of klia2, and dismissed talk of further delays, claiming that the delay in issuing a Certificate of Completion and Compliance (CCC) for the terminal will be resolved "within two to three weeks".

On Feb 4, 2014, contractors UEM Construction Sdn Bhd and BinaPuri Sdn Bhd (UEMC-BinaPuri) said it did not manage to secure the CCC which it had initially committed to acquiring by Jan 31, 2014.

"The contractor made an error where the fire and safety features are not compliant with Fire & Rescue Department's standards so they were asked to do rectifications. Hopefully it can be done within these two to three weeks."

"The major

construction of the terminal is completed. The only issue is the fire and safety features which have been installed but need some rectification," Deputy Transport Minister Datuk Ab Aziz Kaprawi (pix) told reporters during a hastily called media briefing at the Ministry's office yesterday. Various media had reported that the

Various media had reported that the main terminal building was plagued with fire safety, road and drainage and sewerage pipe issues.One issue highlighted was the cracks which arrespondence are an another for blind

appeared on sewerage pipes for kliaz. Aziz however yesterday claimed that the cracks found do not affect the issuance of CCC for the terminal nor the operational readiness and airport transfer (Orat).

"The cracks have nothing to do with CCC. We'll fix it but it has nothing to do with Orat as Orat is only in the terminal," he said.

Aziz said even though Orat officially started on Feb 4, 2014, a few airline already started familiarising themselves with the new terminal earlier.

He explained that the Orat procedure has been split into three phases in order to meet the May 2 deadline.

The first phase, which is a preliminary Orat done by Malaysia Airports Holdings Bhd (MAHB) itself has already started, while the second and third phases will be done in March and April

done in March and April respectively. He said although the

First said antibugin the exact date for Orat was Feb 4, it had already started the procedure last month with some airlines already familiarising themselves with the terminal.

"The other phases (Phases 2 and 3) will be done by the other stakeholders and we've already invited them to

familiarise themselves with the terminal," Aziz said.

He added that contractors which have not complied with the deadline will be "burdened" with liquidated and ascertained damages (LAD).

LAD has been imposed on UEMC-BinaPuri since June 16, 2013 for its failure to deliver the project for the opening which had initially been slotted for June 28, 2013.

Acting Transport Minister Datuk Seri Hishammuddin Tun Hussein meanwhile has reiterated that it will stick to its May 2 deadline for kliaz to begin operations, assuring that it will be

fully operational, with all stakeholders moved in.

"We will be operational on May 2 no matter what. The ministry will not entertain any requests for further extensions," he told reporters at a press conference yesterday, the third he has held since announcing the setting up of the task force to monitor developments at kliaz.

He confirmed that the new terminal will be fully operational on May 2, 2014 with Customs, Immigration, airlines and retailers.

Hishammuddin stressed that he would personally monitor the developments at kliaz and conduct spot checks to ensure that everything is going to plan.

"During the spot checks, I will bring those who can assist such as the ministers concerned or CEOs of the companies involved so that it'll be more specific... so I'm micromanaging to ensure at least on the ministry's side, we've done everything in our power to ensure the public is satisfied that a project of this iconic size fulfils the right standards and transparency," he said. RHB Research Institute Sdn Bhd

RHB Research Institute Sdn Bhd analyst Ahmad Maghfur Usman said in his note to investors that should kliaz see a one quarter delay to the opening date, the revenue loss to MAHB from rentals collected and lower passenger spending is estimated at RM48 million, or L6% of its estimated RM3 billion topline.

"This could potentially shave 10% off our FY14 earnings estimates (RM33.6 million), thus reducing our FV to RM9.61 (from RMR9.80). Note that we have not factored in the daily fine (of RM199.445.40 per day) that MAHB could potentially collect from the JV partners for each day of delay since 16 June 2013 (totalling RM45 million to date). MAHB guided that this will offset the construction bill, which management says will be within the RM4 billion budget for the airport," he said.

KUALA LUMPUR, Feb 5 (Bernama) -- Acting Transport Minister Datuk Seri Hishammuddin Tun Hussein assured Wednesday that the klia2 will open as scheduled on May 2, dismissing a newspaper report that there were serious doubts on the opening date of Asia's biggest low-cost air terminal.

He said the delay to obtain the certificate of completion and compliance (CCC) would not defer the opening of the low-cost carrier terminal.

Malaysia Airports Holdings Bhd said yesterday that it has not received the CCC for the kila2 terminal building from the main contractor, UEMC-Bina Puri.

Klia2 has missed several deadlines for opening with the last one scheduled for April 30 before being moved to May 2.

Hishammuddin said the government would not entertain any request to postpone the opening and that spot checks would continue to be conducted.

Focus would be placed on issues that are preventing the klia2 from being opened as scheduled.

"If there are any quarters who deliberately try to obstruct our plans, I will not hesitate to take action," he told a press conference Wednesday.

Asked if klia2 was ready to undergo operational readiness and airport transfer (ORAT), as required three months ahead of the opening, Hishammuddin said it can be carried out immediately.

"ORAT can take place now but this does not apply to CCC, in fact the testing on the baggage system has to be done... instead we are looking at ORAT, certificate and so on, to me the bigger picture is by May 2, klia2 will begin operations," he added.

Meanwhile, Deputy Transport Minister Datuk Ab Aziz Kaprawi said the low-cost air terminal was almost ready.

"Only the fire and safety requirement system needs to be modified.

"When the Fire and Rescue Department officials inspected the terminal last week, they asked for some modification, that's all.. but the terminal can run smoothly on the ORAT.

"CCC will be issued after a minor rectification to the fire door that is being installed, they just want to change the fire door only," said Ab Aziz, adding that the installation would be completed by month-end.

He said cracks in a sewerage pipe outside the terminal and parts of a road and drainage that were found not fit for use would not delay obtaining the CCC.

"We will fix it, but then it has nothing to do with ORAT because it only involves the terminal," he added.
