## **Bina Puri dapat tender RM49.87 juta**

**Bina** Puri Holdings Bhd menerusi anak syarikatnya, Bina Puri Sdn Bhd, memperoleh tender bagi pelaksanaan projek bernilai RM49.87 juta daripada Brilliant Corridor Sdn Bhd.

Ia bagi kerja membina dan menyiapkan infrastruktur di tanah bersebelahan Stesen 01 bagi cadangan lanjutan Transit Aliran Ringan (LRT) Laluan Ampang ke Putra Heights (Projek Lanjutan LRT Laluan Ampang).

Katanya, tanah di Awan Besar, Bukit Jalil, Kuala Lumpur itu disediakan untuk pembangunan campuran oleh Brilliant Corridor dan Prasarana Malaysia Bhd.

Pengarah Urusan Kumpulannya, Tan Sri Tee Hock Seng, berkata tender daripada Brilliant Corridor itu adalah pengiktirafan kepada keupayaan Bina Puri melaksanakan projeknya tepat pada masa.

### **Terima surat pemberian kontrak**

"Penting bagi projek ini membina kerja-kerja infrastruktur di Awan Besar untuk disiapkan dalam tempoh dengan permulaan operasi di Stesen 01 jika ini bermakna untuk meningkatkan perkhidmatan LRT Prasarana," katanya dalam kenyataan di Kuala Lumpur, semalam.

Dalam kenyataan kepada Bursa Malaysia, Bina Puri mengumumkan, anak syarikatnya itu menerima surat pemberian kontrak (LoA) + daripada Brilliant Corridor, Bina Puri berkata, projek itu dijangka siap dalam tempoh lapan bulan.

Kontrak kerja itu, antaranya, membabitkan pembinaan dan menyiapkan jalan masuk utama yang baharu, penjajaran semula jalan raya sedia ada, laluan bawah, tembok penahan, medan letak kereta dan laluan pejalan kaki berbumbung.

## Bina Puri gets RM50m project from Brilliant Corridor

**KUALA LUMPUR:** Bina Puri Holdings unit Bina Puri Sdn Bhd has won a tender to undertake a RM49.87mil project from Brilliant Corridor Sdn Bhd.

Bina Puri is to construct and complete the infrastructure works on a land next to Station 01 of the proposed extension of the Light Rail Transit Ampang Line to Putra Heights.

The land in Awan Besar, Bukit Jalil, Kuala Lumpur, is being prepared for mixed development by Brilliant

Corridor and Prasarana Malaysia Bhd.

Group managing director Tan Sri Tee Hock Seng said that the tender award by Brilliant Corridor was a sterling recognition of Bina Puri's capability to deliver its undertakings on time.

"It is crucial that this project to construct infrastructural works at Awan Besar must be completed in time with the commencement of operations at Station 01 if this were to mean any-

thing to enhance Prasarana's LRT services," he said in a statement yesterday.

Bina Puri said the project should be completed within eight months.

## Bina Puri bags RM50m infrastructure job

**KUALA LUMPUR:** Bina Puri Holdings Bhd, via its wholly-owned subsidiary Bina Puri Sdn Bhd, has bagged a RM49.87 million contract from Brilliant Corridor Sdn Bhd for infrastructure works on a piece of land at Awan Besar in Bukit Jalil. The land is adjacent to Station 01 of the proposed extension of the light rail transit (LRT) linking the Ampang Line to Putra Heights.

The land is being prepared for a mixed development called "Station 01" by Brilliant Corridor and Prasarana Malaysia Bhd.

This brings the total new projects the group has secured this year to RM695 million and unbuilt order book to RM2.01 billion.

"The infrastructure project was awarded by Brilliant Corridor Sdn Bhd on Nov 10 and it is to be completed within eight months," said Bina Puri.

"It is crucial that this project to construct infrastructural works at Awan Besar [is] completed in time with the commencement of operations at Station 01 if this were to mean anything to enhance Prasarana's LRT services," Bina Puri group managing director Tan Sri Tee Hock Seng said.

The works entail, among others, the construction and completion of a new main access road, realignment of existing roads, underpass, vehicular box culverts, retaining walls, surface car parks, and covered walkway. It also involves the installation of street lighting, traffic signalisation and upgrading, drainage and road furniture, and landscaping.
