Bina Puri bags RM129m job to build Terengganu spa resort

KUALA LUMPUR: Bina Puri Holdings Bhd has bagged a RM128.5 million contract to build a spa resort to be known as Movenpick Spa Resort in Kuala Terengganu, Terengganu.

In a filing with Bursa Malaysia yesterday, Bina Puri (fundamental: 0.15; valuation: 1.8) said its wholly-owned subsidiary Bina Puri Sdn Bhd had on Feb 27, 2015 received a letter of award from Success Diar

Sdn Bhd to undertake the proposed project. It added that the project is expected to contribute positively to the net assets and earnings of Bina Puri Group for the financial year ending December 2015.

In a statement yesterday, Bina Puri group managing director Tan Sri Tee Hock Seng said with this latest contract, the group's unbuilt order book stands at RM1.86 billion as at to date.

"We are confident of securing

more projects in the upcoming year," he said. He added that the Bina Puri group has been actively participating in the tender for projects both local and overseas, but he did not elaborate.

Located on a 25-acre (10ha) beachfront site at Chendering Beach, the proposed spa resort will feature eight blocks of 2-, 3- and 5-storey buildings, nine pavilions, a spa and a multipurpose building and related facilities.

Bina Puri bags RM128.5m spa resort project

PETALING JAYA: Bina Puri Holdings Bhd has clinched a RM128.5 million contract to construct a spa resort complex in Kuala Terengganu, called the Movenpick Spa Resort.

The contract was awarded by Success Diar Sdn Bhd on Feb 27, 2015 and will be undertaken by Bina Puri's wholly-owned subsidiary, Bina Puri Sdn Bhd.

The project involves the construction, supervision, testing and commissioning as well as completing eight blocks of two-storey, three-storey and five-storey high buildings, nine pavilions,

a spa and a multi-purpose building and related facilities (Package 2).

The Movenpick Spa Resort is located on a 10.1ha beachfront site at Chendering and is scheduled to be completed in 22 months.

Bina Puri group managing director Tan Sri Tee Hock Seng said he was proud of securing this contract as it marked the group's return to Terengganu after a decade.

In February 2002, he said the group had successfully completed a road upgrading project from the roundabout Sultan

Mansur to Kuala Berang stretch (package 2A) costing RM26.5mil.

"Our re-entry in Terengganu can only mean the group is prepared to expand and consolidate our business operations nationwide. With this contract, the Group's un-built book order stands at RM1.86 billion as at to date," he said in a statement yesterday, adding that he was confident of securing more projects in the upcoming year.

The company said it has been actively participating in the tender for projects both local and overseas.

獎掖計劃奏效 PRS年輕會員增3倍

青年獎掖計劃奏效，2012年推出的私人退休計劃（PRS）規模2年內倍增，年齡30歲以下會員人數從2013年7%，去年增3倍至22%。

蘭吉阿吉在匯報會上指出，截至今年2月，私人退休計劃下管理資產總額為7億8500萬令吉，會員人數共13萬4656人。

他透露，年齡超過60歲的會員人數占總數6%，55歲至60歲會員占8%，50歲至55歲會員占12%，40歲至50歲則占27%。

“30歲至40歲會員占總數25%，值得一提的是，30歲以下會員人數按年激增，從2013年僅7%，增至去年

22%，青年獎掖計劃成功擴大會員年齡層。”

政府在青年獎掖計劃下，為年齡介20至30歲的會員，提供500令吉獎掖。

報告指出，截至去年底共有11項私人退休計劃，其中包括46項退休基金，淨資產總值達7億1605令吉，按年增1.4倍。

另外，私人退休計劃的分銷渠道亦擴大至涵蓋保險和伊斯蘭保險中介，除了新增中介類別，證監會亦推出新計劃，讓投資聯結保險的代理加入分銷網絡，旨在推廣和提高私人退休計劃的素質。
