Bina Puri menang projek loji kumbahan RM291.2 juta

KUALA LUMPUR 26 Mac - Syarikat pembinaan utiliti, Bina Puri Holdings Bhd. (Bina Puri) menerima kontrak untuk melaksanakan projek Pembinaan Loji Rawatan Kumbahan Serantau Bunus, Kuala Lumpur, daripada Jabatan Perkhidmatan Pembetulan, Kementerian Tenaga, Teknologi Hijau Dan Air bernilai RM291.2 juta.

Menerusi konsesi bagi tempoh

20 tahun akan datang itu, ia membolehkan Bina Puri menyediakan perkhidmatan lebih baik susulan peningkatan penduduk di kawasan berkenaan.

Bina Puri gets RM292m KL sewage treatment plant

KUALA LUMPUR — Bina Puri Sdn Bhd, a wholly-owned subsidiary of Bina Puri Holdings Bhd, has won a massive RM291.16 million sewage treatment plant project to provide for the expected increase of urban dwellers in Setapak for the next 20 years.

This award to expand and upgrade the existing Bunus Regional Sewage Treatment Plant at Jalan Chan Chin Mooi, Titiwangsa, will increase its treatment loading capacity of sewage discharges by three times of 1.1 million residents expected by 2035.

Bina Puri Holdings Bhd group

MD Tan Sri Tee Hock Seng said in a statement to Bursa Malaysia that its subsidiary Bina Puri Sdn Bhd has been awarded the contract by the Sewerage Services Department under the Ministry of Energy, Green Technology and Water on March 20 this year.

The project will be completed within 18 months. It entails the construction, equipping, testing and commissioning of the Bunus Regional Sewage Treatment Plant, including maintenance of the project for 12 months. It will involve the laying of 36km of sewage pipes that will cater to the expected growth of residential

and commercial real estate within Setapak.

"With this award, we have managed to secure RM419.66 million (worth of) projects in the first quarter of this year and (are) confident there will be more opportunities to secure further projects by year end.

"The project is expected to contribute positively to the net assets and earnings of Bina Puri Group for the financial year ending December 31, 2015," he said.

PETALING JAYA: Construction services provider Bina Puri Holdings Bhd has secured an RM291.16mil project from the Government to build a sewage treatment plant in Titiwangsa, Kuala Lumpur.

The project, to be completed in 18 months, entails the construction, equipping, testing and commissioning of the Bunus regional sewage treatment plant, including the maintenance of the project for 12 months.

"The award is to expand and upgrade the existing Bunus regional sewage treatment plant at Jalan Chan Chin Mooi, which will increase its treatment loading capacity of sewage discharges to handle additional sewage discharges of 750,000 residents in the vicinity," managing director Tan Sri Tee Hock Seng said in a statement.

Bina Puri gets boost from government contract

KUALA LUMPUR: Bina Puri Holdings Bhd's unbuilt order book has grown to RM2.11 billion after it clinched a RM291.16 million contract from the Energy, Green Technology and Water Ministry to build a sewage treatment plant at the existing Bunus regional sewage treatment plant site in Setapak, here.

Bina Puri (fundamental: 0.15; valuation: 2.4) said its wholly-owned subsidiary Bina Puri Sdn Bhd had accepted a letter of award from the ministry last Friday for the

proposed project, which will take 18 months to complete.

"With this award, we have managed to secure RM419.66 million in projects in the first quarter of 2015 and we believe there will be more opportunities to secure further projects by year end," Bina Puri group managing director Tan Sri Tee Hock Seng said in a statement yesterday.

The project is expected to contribute positively to the group's net assets and earnings for the financial year ending December 2015.

Tee said the proposed project on a 19.388ha site will increase the Bunus regional sewage treatment

plant's treatment loading capacity to handle an additional sewage discharge of 750,000 residents in the vicinity.
